

## **CHARITY/DONATION REQUEST POLICY**

This policy is implemented for any request made to Rommel Harley-Davidson dealerships.

## **POLICY**

It is the policy of Rommel Harley-Davidson to review and give fair consideration to all requests from <u>LOCAL</u> community organizations and charities. Rommel Harley-Davidson does not make cash donations, sponsor organizations, or donate motorcycles.

Approval of charity/donation requests are granted based on budgetary allotments and working relationships with the organization, with emphasis on police and fire/rescue, veterans, animal welfare and those organizations championed by the biker community. While we strive to approve all requests, the demand simply outweighs our supply. Priority will be given to events which include Rommel dealership locations.

Budget considerations and decisions for all requests will be done on an annual basis in December for the future year. After the annual approval, community giving will be considered on a case-by-case basis during the balance of the year, if budget dollars remain.

## **PROCEDURE**

- 1. All requests must be submitted on Rommel Harley-Davidson Charity/Donation Request Form to the dealer specific contact as listed on the form. It is recommended that the organization submit supporting documents, along with this form. We wish to know about the requesting organization, its history and mission, event details, and the importance of a donation from Rommel Harley-Davidson.
- 2. Submit the request form to the Rommel Harley-Davidson contact. Please be sure to give ample time for review of your request, if submitting after the December annual review deadline. Please allow a <u>MINIMUM OF 60 DAYS</u> for review and action on your request.
- 3. Approval decisions are made by the dealership.
